# Bella Safe Cover Plan

## COVER PLAN

We require you as the hirer to ensure you are covered at all times if the machine is stolen or severely damaged therefore we highly recommend that you have some form of hired in plant insurance, however if you have not got any insurance we can offer a damage waiver scheme, this will not cover you if the machine is stolen but will help you the machine is accidentally damaged. Please be aware it is still your responsibility if anything happens to the machine.

Our platinum damage protection plan covers you for the following:

## COVER

## COST:

20% onto the hire cost of the machine.

## WHAT'S INCLUDED IN THE COVER:

Provides the Hirer with protection against the cost of repair of the equipment following accidental damage, vandalism or malicious damage.

## WHAT'S NOT INCLUDED IN THE COVER:

- The first £1000 of any claim
- Malicious Damage or vandalism during non-working hours, if the equipment is not stored securely and locked away when not in use
- Paint overspray
- Damage caused by failure to maintain Lubricant and coolant levels
- Damage caused by failing to maintain the batteries
- Damage Caused by failing to maintain the tyre pressure correctly
- Damage to filters and fuel lines due to the use of contaminated fuel
- Damage resulting from overloading or mis-use
- Damage by fire when hot work is being undertaken
- Damage to third party property or persons
- Damage Caused by Chemicals
- Damage while on unauthorised hire or loan to another party

You only pay for the Cover when you have a machine on hire

Bella Safe is a special indemnity scheme operated by Bella Access Ltd. Whilst **NOT an insurance policy** it offers customers an indemnity against machine damage subject to them meeting basic obligations under the hire contract.

Failure to adhere to any of the terms and conditions may invalidate any claim.

All equipment is hired under CPA Terms & Conditions 2011

**Bella Access offers the “Bella Safe” Damage & Loss Waiver Scheme to customers wishing to protect themselves against liability for damage or loss to hired equipment, assumed under the CPA terms of the hiring agreement, while at locations within the UK.**

**Terms and Conditions – Self operated hires**

Bella Safe Waiver scheme benefits are extended to the hirer in exchange for a set premium on the hire rate. Cover will be provided at the stated level on the hire order confirmation provided that:

1. Operators of the equipment have undergone an industry recognised training course and hold a valid licence for the particular class of equipment. Powered Access operators shall hold a valid PAL licence for the category of MEWP.
2. The equipment is operated in accordance with the Manufacturer instructions.
3. ALL equipment is stored in a locked building or compound when not in use outside normal working hours.
4. Daily and weekly safety inspections are carried out which include but shall not be limited to oil, water, battery, fuel, and safety systems. Weekly inspections shall be documented.
5. Any damage is reported to the hiring branch as soon as it is discovered and always before it is returned / collected.
6. Theft, malicious damage, and vandalism is reported to the Police as soon as it is discovered, and a crime reference number obtained.
